At June Meeting, we will have a more focused conversation as the team details a plan for the upgrade.

UCF Program Updates

- EAB federal quarantine ended, but VT continues to support slow the spread messaging.
- Federal funding will be limited, so messaging, and funding for Forest Pest Outreach position should be broader, not solely focused on EAB.
- EAB Awareness Week- kits to celebrate locally, not in person
- Grants in progress- 10 communities removing ash, planting other species, etc. (Funded by special Forest Service Funds)
- Black Ash Discussions with Chief Don Stevens and basket makers, concerns and wishes for black ash for basket making and considering future of black ash in our forests. Discussions include working with Forest Service. Stay tuned for more in how these piece will come together.
- EAB infested area map that will have more context. Map is in draft form, but hope to help decision makers as it will highlight higher impact, older infestations, etc.
- Tree Warden Support
 - Starting tree warden school on March 15.
 - Tree Warden Contact information reporting button is live!
 - VLCT contract: will be providing online trainings for tree warden support
 - o Shade Tree Preservation Plans: 10 communities working on drafts.
- Seeking 2 reviewers for Arbor Day tree planting grants and 2 reviewers for Tree Steward Awards
- Federal UCF budget increase: grant opportunity to focus on canopy enhancement, public health
- Vermont Community Canopy: DEC Air Quality settlement funds for 2 years

Legislative Updates

- Danielle Fitzko shared legislative updates from FPR
 - Use Value Appraisal/Current Use amendments proposed to add a category focused on forest
 - o COVID-19 funding, infusion of funds for state lands and recreation.
 - Act 250 proposed changes: trails, new oversight.
 - Global Warming Solutions Act and their proposed process to have guidance/report for public review by October, finalized by the end of 2021.
 - Question from Sara Packer regarding a proposed change to the Vermont Pesticide Use Council.
- Richard Amore shared updates from Agency of Commerce and Community Development
 - Better Places Overview
