

What is Tree Equity?



Communities of color and lower income communities have **36-45% less tree cover.**

And are **6-9°F hotter** than wealthier and whiter communities

INFLATION REDUCTION ACT

\$1.5 billion for the U.S. Forest Service's Urban & Community Forestry Program to help communities plant & care for urban trees.

IMPACT:

This funding will enable the planting & protection of more than 23 million trees, advancing environmental justice, health, and quality of life for communities nationwide.

BENEFITS INCLUDE:




3 trees from every home

Tree Equity Score


- Score: 0-100.
- Lower the score, the greater the need for investment.
- 7 climate and socioeconomic characteristics:
 - children/seniors
 - linguistic isolation
 - health burden index
 - heat disparity
 - people in poverty
 - unemployment
 - people of color
