Federal and State Program Updates

- Federal Program Updates
 - Haven't received FY24 funds (which funds Gwen's position)
 - Reason for lag: UCF receives \$1.6 billion annually, however the grants department has been slammed and unable to get everything; would like to bundle FY24 & FY25
 - IRA funding is out UCF funding will be pushed out quickly
 - There is concern for the new administration; have sub-awardees invoice often and soon (expect an unpredictable first couple of months)
 - Administration change the last administration awarded \$0 to UCD, however, strong advocates pushed for funding, which UCF received; need to lean on partners to push
 - Storytelling is a big theme so we can push our work and why it's important
 - National UCF Program is currently revising their 10-Year Action Plan
- State Program Updates
 - Staffing UCF program is fully staffed (5 team members)
 - Forestry Division Strategic planning is in progress
 - ARPA \$1 million
 - Funds Adam's position not at risk of losing funding
 - FEMA Project
 - Navigation assistance with buyout properties
 - Not funded; small working group with Vermont Land Trust and Vermont Community Development
 - USFS Landscape Scale Restoration Project submitted
 - Continuation of Women in the Woods
 - One-time funding request: Vermont Community Canopy and Tree Planting Grant
- 2024 Highlights
 - Technical and educational assistance FY24
 - 132 Communities assisted
 - UCF Database made by IT to track community metrics (can give access to UCF Council members)
 - 112 district-assisted events
 - 11,000 volunteer hours

- Grants
 - Over \$1 million to give out
 - UCF (IRA) \$500,000 match-free 12 projects
 - USFS eliminated Growing Urban Forests in EAB
 - Communities Caring for Canopy
 - Community tree planting events (ARPA)
- 2025: \$430,000 available; applications due January 10th
 - Two categories: Planting and Maintenance/Removal
- Savannah and Evan volunteered to serve on Communities Caring for Canopy
- Vermont Community Canopy
 - Gwen's program
 - Crested the 5000-tree mark; 1500 trees given out
 - ARPA funding extended to 2025; planning for contract growing in 2026
- UCF program had 3 interns over the summer: Lila Turner, Tate Mullins and Dominick, who
 worked on a storymap titled \$3 million over 30 Years, worked on arboricultural skills, and worked
 with an attorney to create a liability agreement
- Recognition:
 - Gwen: Leahy Institute Recognition, nursery tour at the Intervale
 - Ginger: Forest Pest detection for outdoor recreation organizations and trail managers (106 participants), Arrive Clean, Leave Clean campaign
 - Adz: inroads with BGS and AoT led pruning workshops on BGS properties
 - Joanne: Town Forest Stewardship toolkit, will be attending the Green Communities
 Leadership Institute
 - Elise: New England ISA Vermont State representative, member of the ANR Environmental Justice Working Group
- Chicago Conference
 - National Urban Tree Canopy Map/Layer: help guide communities on improvements
 - <u>Tree Equity Score</u> (National Explorer): places without tree canopy because of no investment
 - Equity Handbook: how to build stakeholder trust and investment
 - The Canopy Report: survey result want more urban forestry and trees
 - Green Schoolyards America: push more strategic afforestation of schoolyards
- Affinity groups across can look outside for Vermont for help
- Municipal Conference: technology to advance tree management and for social sciences

Vermont Town Forest Census Update

- 67,000+ acres in 168 municipalities in Vermont (as of 2007)
 - Provide information to assist organizations, universities and towns
- Census try to get response from every member of the population
- Why census now?
 - Want to update the list of forest areas surrounding local government entities
 - Get perspectives from the communities themselves
 - Build community, share information and lay groundwork for peer learning

- Multi-Step
 - Develop advisory community and guide definitions and focus
 - Census form developed in Qualtrics with iterative review
 - Outreach to every Vermont town: how many forests? Who is the 'steward' of each?
 - Deploy census by forest in cohorts
 - Match mapping efforts when census is returned
- Preliminary findings from Cohort #1
 - Sent to 135 forests in 10/25/24
 - 78 responses to date: 17,426 acres
 - Average 223-acre forests
 - Minimum: 7 acres
 - Maximum: 1650 acres
 - Preliminary analysis in highlights:
 - Challenges stewards face
 - Assistance needs/interests
 - Post-Covid trends
 - If time: casting too wide a net for "town forest" focus
- Challenges
 - 8 major challenges;22 minor
 - Top challenges (major)
 - Ensuring access
 - Constructing and maintaining for managing trail network
 - Securing funding
 - Top challenges (minor)
 - Protecting ecological features and functions
 - Managing conflicts
 - Finding volunteers
 - Communities' awareness of forest
- Top interest topics
 - Invasive species
 - Monitoring wildlife and environmental impacts
 - Trail/road maintenance
 - Opportunities to learn from other town forests
 - Ecological assessment
- What is a town forest?
 - Lots of forest land not known as 'town forests'
 - Local definitions collected
 - Parks and conservation areas
- Land Management Records Community owned forests in New England
 - Goes back 400 years
 - Community woodland part of town planning history
 - Town forests represent the first campaign on parts of towns
 - Introduced scientific forestry practices in the communities

Strategic Planning (Setting the State)

- Defined problem:
 - Program has changed and matured over the part of 30 years. The structure and function of Council adapted to meet these changes
 - Lack of clarity as to specific role of the Council is currently, there is a supply and demand issue: we have a supply of expertise in members but is unclear what is the demographic from staff and program
 - No strategic plan for program: 5-Year Action plan has been used since 2016 doesn't identify long-term goals

Revisioning the Council Format & Schedule

- Proposed changes to the Vermont UCF Council:
 - Eliminate the executive committee
 - Revisit council representation (14 assigned, 6 ad hoc)
 - Pilot UCF subcommittees
- Launch New Schedule
 - January June: at least one subcommittee meeting
 - June 11th field trip
 - June December: at least one subcommittee meeting
 - December 10th in-person meeting in Montpelier

Proposed UCF Council Subcommittees

- Agency Partnerships & Collaboration (Elise)
 - Cross-agency and organization collaboration
 - Gaps + funding
 - Coordination among tech assistance provides and reduces competition for limited volunteer capacity/bandwidth
 - Bring in county foresters more we do so much with community forests Tessa can help

- Identify intersecting areas (Venn Diagram) can help identify partner resources/expertise
- Understand relevant programs at other agencies and areas for connectivity
- Joint program (fund and design) to plant trees on VTrans municipal projects
- Connect funding sources that different departments/agencies offer to promote urban and community forestry
- Grown workforce with Eco AmeriCorps in December
- Identify conflicting goals/objectives between Agencies as related to urban and community forestry
- Money: Program Support & Sponsorship Committee (Gwen) & Non-Profit Model for UCF in Vermont (Joanne)
 - Provide program with increased flexibility for programming (Gwen)
 - Discuss current logistics and funding gaps presented by the lack of a Vermont-based non-profit on urban and community forestry to identify models of non-profit formats that could grow into filling the gap (Joanne)
 - Tap into organizations or nonprofits who have money and an overlapping mission
 - Small grant applications
 - Clearly identify what money can/will be used for
 - ACCD conference could be a precedent for this
 - Public/private partnerships see conversation finance network
 - Draft fundraising letter list of potential funders
 - Identify specific business/corporate sponsorships meetings, conferences, initiatives, tree planting
 - Opportunities for investment targets for investment? Who to ask?
 - Huge need for money/assistance for trailer parks!
 - Scan potential existing nonprofits with similar objectives, alignment with goals (look at USFS Stewardship mapping resources)
 - Understand demand do we need more nonprofits?
 - Survey tree/community forestry non-profits with other similar states for their structure, etc. (NYC does public partnerships well)
 - Clarify what kinds of projects/activities this nonprofit would be involved with
 - Similar model as Vermont Parks Forever?
- Arboriculture Subcommittee (Adz)
 - Municipalities to integrate trees as infrastructure
 - Form network of ISA Certified Arborists willing to donate time to train and advise municipalities
 - Network for Vermont based arborists to share/promote training opportunities, could trickle down to local decision-makers
 - ullet Hotline ullet centralized location for questions, group of volunteer arborists who respond
 - New specs for planting and maintenance for UCF grants
 - Maybe circle of arborists who go where needed
 - Ask town managers what they need, base outreach on needs
